
### **Event Overview**

- → Infrastructure Development: Evaluation of allocations for roads, railways, airports, and other infrastructure projects.


- Agriculture and Rural Development: Discussion on schemes and initiatives aimed at boosting agricultural productivity and rural income.

- Taxation: Explanation of changes in income tax slabs, corporate tax rates, and other tax-related measures.




Throughout the discussion, students were encouraged to ask questions and participate actively. The faculty panel provided clear and insightful explanations, fostering a lively and interactive learning environment.

## **Student Participation**


