This concession is applicable every year as student progresses in his/her studies at any PES Institution. However, the following terms and conditions apply for availing this concession:

1. Applications shall be submitted to CCA through the Principal of the concerned Institute.
2. Concession shall be given only in tuition fees.
3. In Diploma, Engineering, MBA & M.Com courses concessions can be given for the admissions under Management Quota only.
4. Principal of the concerned institute needs to certify all cases availing this concession.
5. If both parents are working at PES Group and/or sister institutions/organizations, applicable concession as detailed above plus an additional concession of Rs.2,000/- is allowed in the tuition fees.
6. Discontinued/Detained students even if they re-join the course later after eligibility; they are not entitled for this concession.
7. Failed students are not eligible for concessions starting from the next Academic Year.
8. The concession is available only to the children of staff members and not for their relatives.
9. If the student discontinues the course in the middle of the academic year/semester for any reason whatsoever; amount of concession is deemed to be cancelled and full eligible fees has to be paid by the parent.
10. If any staff member availing rent free accommodation; employee is entitled to the fee concession as per Column No.3 in the above table.
11. A maximum of number of students eligible for this concession will be restricted only two children.
12. The eligible parents have to produce a copy of the ID confirming their employment at PES institutions, sister institutions and/or sister organizations. Authorization letter required from sister institutions/organizations.
13. Amount of concession offered may be changed or withdrawn without assigning any reasons.
