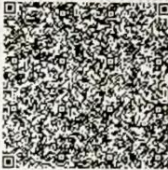

D) Intellectual Property

5. Should the collaborative research activities under this MOU result in any potential for intellectual property, each shall seek an equitable and fair agreement as to ownership and other property interests that may arise according to the rules and regulations of the two institutions.

E) Coordination

6. 9. A select group of students from both institutions will visit the collaborating institutions to study possible research areas, or to conduct research activity or academic pursuit.

G) Terms and Termination

10. This MOU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for the period of **five years**, and may be continued thereafter after suitable review and agreement.
11. This MOU may, at any time during its period of validity, be terminated by one of the parties upon prior notice to the other in writing not later than six months before the termination date. Once terminated, neither PES Institute of Advanced Management Studies, Shivamogga, Karnataka a nor Kumadvathi First Grade College, Shikaripura, Karnataka, will be responsible for any losses, financial or otherwise, which the other institutions may suffer. 5. Should the collaborative research activities under this MOU result in any potential for intellectual property, each shall seek an equitable and fair agreement as to ownership and other property interests that may arise according to the rules and regulations of the two institutions.

E) Coordination

6.
