By-Laws of PESIAMS Alumni Association

The Official Name of the Association: PESIAMS Alumni Association

Address: PES Institute of Technology & Management (PESIAMS) NH-206, Sagar Road, Shivamogga - 577 204

1. Name of the Association:

The name of the Association shall be PES Institute of Advanced Management Studies Alumni Association, hereinafter referred to as PESIAMS Alumni Association (PESIAMSAA).

2. Office:

The Registered Office of the PESIAMSAA shall be located at PES Institute of Advanced Management Studies, NH-206, Sagar Road, Shivamogga 577 204, Karnataka, hereinafter called the Institute.

3. The Objectives of the Association

3.1 Alumni cell shall continuously involve in the betterment of Alumni fraternity through strong bondage and contribution to the welfare of the Alma Mater.

3.2 To encourage the Alumni to take interest in the progress and development of the Alma Mater by assisting the faculty and students of PESIAMS in various value-addition activities like curriculum development, sponsored research projects, case study development, student internships, and enhance job opportunities by providing necessary information to the Training and Placement Cell.

3.3 To conduct Alumni-Students Knowledge Exchange Programmes (ASKEP).

3.4 To enhance PES Institute of Advanced Management Studies brand by promoting professional excellence, entrepreneurial development and by extending possible Corporate Social Responsibility (CSR) service to the local community.

3.5 To award one time prize money/ medals to the University rank holders.

3.6 To construct the Alumni building for the purpose of implementing the objectives.

3.7 To raise funds for the development of PESIAMS and PESIAMSAA.

3.8 The Association shall be a non-profit organization.

4. Organization of the Association

4.1 Patron: One of the Governing Council members nominated by the Managing Trustee shall be the patron of PESIAMSAA.

4.2 President: Principal shall be the Ex-officio President.

4.3 Members: The association shall have the following categories of members (hereafter referred to as members).

4.3.1 Life Members: Those who have received degrees awarded by/ through the Institution (referred as Alumni)

4.3.2 Associate Members: Students who have studied at least one year in the institute and remitted the membership fee shall be eligible to be the Associate members. The past and present faculty members of PESIAMS, who are not alumni of the college, are also eligible to become Associate Members of the Association on payment of the prescribed membership fee.

4.3.3 Honorary Members: The following individuals may be granted Honorary Membership of the Association for a period decided by the Executive Committee: The person who has rendered distinguished services to the cause of Technical/ Management Education; person who has exhibited excellence in Industries/ R&D organizations; person who has contributed to social causes or philanthropists. Deans and all the faculty members who are not the alumni of the institute shall be honorary members till such time they hold their offices.

5. Membership Fee

The Life Membership and Associate Membership shall be granted on submission of application form and payment of one-time fee of Rs 200 by the eligible individual undergraduates and postgraduate students who come under PESIAMS.

6. Duties of the General Body


- 6.1 Members of the association shall comprise the General Body of the Association.
- 6.2 A general body meeting shall be held at least once in every financial year.
- 6.3 The mode of holding the meeting including the place, date, time and agenda shall be convened under the President as the Executive Committee may decide.
- 6.4 The opinion of the General body of the Association shall be supreme in taking any decision regarding amendments to the Constitution and by-laws.
- 6.5 To set guidelines for the Executive Committee so as to achieve the objectives of the Association.
- 6.6 To consider and adopt the Annual Report and Audited Accounts of the Association.
- 6.7 To approve the budget for the following year.
- 6.8 To elect office bearers and members of the Executive Committee.
- 6.9 To transact any other activities beneficial to the students and staff community with the permission of the President.

7. The Executive Committee (EC)

There shall be an Executive Committee for the management of the affairs of PESIAMSAA and shall comprise of the following members as Office Bearers:

7.1 Office Bearers:

- 7.1.1 **President:** The Principal in service of PESIAMS, Shivamogga is the Ex-officio President
- 7.1.2 **Vice-President:** (Elected among the Alumni)
- 7.1.3 **Secretary:** (Elected among the faculty of PESIAMS)
- 7.1.4 **Joint Secretary:** (Elected among the Alumni)
- 7.1.5 **Treasurer:** (Elected among the faculty of PESIAMS)
- 7.1.6 **Four Members:** (Elected among the Alumni)

7.2 The Executive Committee shall be in force for two years.

7.3 If any member of the Executive Committee remains absent for three consecutive meetings, he shall be deemed to have resigned from the EC.

8. Duties of the Executive Committee

8.1 The Executive Committee (EC) shall have the full control over the management of all the affairs and the funds of the association, and shall have authority to exercise all the powers of the Association. The EC shall meet whenever the need arises to transact the following business:

8.2 To prepare and execute detailed plans and programmes for the establishment of the association and to carry on its administration and management, and various activities.

8.3 To review the progress of any developmental activity taken-up under the joint auspices of Institute and Alumni Association.

8.4 To appoint sub-committees and delegate powers to its members to carry out specific purpose for specific period.

8.5 To consider and pass the annual reports, financial estimates, accounts, etc. of the association and consider any recommendations made at a General Body Meeting.

8.6 To borrow or raise money that may be required by the association from such sources including nationalized banks and on such terms as may be deemed desirable by the EC.

8.7 To award one time prize money/ medals to University rank holders.

8.8 To approve any action taken/ payments of outstanding bills of legitimate expenditure/ any legitimate payment made by the working President in anticipation of such approval by EC.

8.9 To consider and approve the contribution of financial assistance from the Alumni Association funds towards developmental activities of the Association.

8.10 Enrollment of members and collection of funds.

8.11 To sue and defend all legal proceedings on behalf of the association.

8.12 Any other matter in consonance with objectives of the Association.

8.13 The Quorum for the Executive Committee meeting shall be five. In case there is no quorum, the meeting shall be adjourned.

8.14 The decision made in the EC is deemed to be passed if supported by a simple majority of the quorum.

9. Duties of the Office Bearers

9.1 Patron:

9.1.1 Shall advise the EC regarding the smooth and efficient functioning of PESIAMSAA.

9.1.2 Shall decide about any unresolved dispute(s), and the decision of the patron shall be final and binding on Executive Committee and General Body of PESIAMSAA.

9.2 President:

9.2.1 To preside over and conduct all the meetings and Executive Committee meetings of the Association.

9.2.2 To represent the association for all the matters.

9.2.3 May appoint groups, sub-committees, etc. and nominate representatives of PESIAMSAA on vacancies.

9.3 Vice-President:

In addition to his duties as a member of the Executive Committee, he shall act as President and preside over committee meetings in the absence of the President.

9.4 Secretary:


9.4.1 The Secretary shall attend to the day-to-day correspondence and communications to and from PESIAMSAA

9.4.2 He shall be responsible for convening the meeting of the EC and General body in consultation with the Patron and President by issuing a prior notice of 15 days.

9.4.3 He shall be the official custodian of all records, minute books, account books, cheque books, correspondence and seals of the association.

9.4.4 He shall supervise in consultation with the Patron and President the progress of those developmental activities in which the Alumni Association is involved.

9.4.5 He shall be responsible for filing of Annual Reports of PESIAMSAA with the Registrar of Societies after every Annual and other Special General Body Meetings, Financial Statements with the Income Tax Officer along with the Treasurer, and such other statutory requirements.

9.5 Joint Secretary:

9.5.1 He shall assist the Secretary in all activities of the association.

9.5.2 To carry-on all the work assigned to him by the President and the EC.

9.5.3 In absence of the Secretary, Joint secretary shall act as the Secretary.

9.6 Treasurer:

9.6.1 The Treasurer shall maintain correctly all the accounts, account books and records related to finance of the Association.

9.6.2 He has to keep a strict vigil on the accounts and payments, and is responsible for financial transactions of PESIAMSAA.

9.6.3 He has to collect the funds for the association in consultation with the President and as per the decision of the EC.

9.6.4 He shall ensure that two signatories operate the account. The cheques will be jointly signed by the President with mandatory signature of the Treasurer.

9.6.5 He shall get the audited statements of PESIAMSAA by a Chartered Accountant and prepare for presentation at the Annual General Body Meetings and file the same with the Income Tax authorities when duly passed by the EC.

10. Annual General Body Meeting

10.1 The Annual General Body Meeting (AGBM) of the Association shall be held every year on the date specified by the EC. The date and time of the meeting shall be notified by the President through the Secretary with a prior notice of 15 days.

10.2 For the purpose of taking the opinion of the General Body on specific issues, the President may also convene special meetings of the General Body. Special meetings of the General Body may also be requisitioned by a member of the General Body provided that such a request has the support of at least 25 other members and the request is made at least 30 days in advance of the proposed date of the special General Body meeting. The business of special meeting shall be confined to the specific matter(s) for which it has been called and no other matters shall become admissible for the discussion.

10.3 The venue for holding the meetings shall be decided by the Executive Committee.

10.4 The EC shall be empowered to propose motions at any time of the year for the consideration and voting by the General Body.

10.5 In addition to voting by members present in the General Body Meeting, any matter that requires a voting by the General Body of alumni may also be done by secure electronic media and/ or postal voting. EC members shall not be involved in the counting/ tallying of the votes; an Election Officer appointed by the EC from among the employees of the Institute will ensure the secrecy and correctness of the vote and tally. The tally of the electronic votes and postal votes will be taken in advance but will be publicly revealed by the Election Officer just after taking the vote of the members present in the GBM.

10.6 All decision/ motions shall be deemed to be passed if supported by a simple majority.

10.7 Quorum for the General Body meeting shall be a minimum of 1/3rd of the members or 50 members.

11. Elections

11.1 All the elected posts of the new Executive Committee shall be filled by the elections in the Annual General Body Meetings to be held every alternate year.

11.2 Elections shall be conducted by an Election Officer, appointed 30 days in advance by the outgoing EC.

11.3 On behalf of the EC, the Election Officer shall be responsible for receipt, scrutiny, acceptance and display of nominations, the acceptance of withdrawals and the actual conduct of the elections.

11.4 Only the Life Members of the Association shall have the right to vote, propose, second or be a contesting candidate for any office open for election in the Association. Associate Members and Honourary Members shall enjoy all the privileges of the Association, however, they shall not have any voting rights and cannot contest in the election for office bearer posts.

11.5 Nominations shall be invited at least two months in advance of the AGBM of alternate years by the general circular to all members. By-Laws of PESIAMS Alumni Association

11.6 Every nomination shall be required to be duly proposed and seconded by members of the Association and shall contain a proper consent of the nominee.

11.7 After the closing date of the nominations, all valid nominations for all the posts shall be brought to the knowledge of the General Body by the Election Officer.

11.8 In addition to voting by members present in the Annual General Body Meeting, voting may also be done by secure postal voting. Results of the voting shall be announced by the Election Officer.

11.9 The new Executive Committee shall take over the charge of the Association within one month of its election.

12 Financial Management

12.1 The membership fees, other contributions from the members, donations, sponsorships from external agencies, proceeds from various activities, etc. shall constitute the income of the Association.

12.2 The Executive Committee shall have the power to decide from time to time the membership fees to be collected from the new members.

12.3 The individual incentive/ prize money/ cost of medal should not be in excess of twenty prevailing membership fee.

12.4 The funds of the Association shall be maintained in a separate bank account in the name of the PESIAMS Alumni Association in State Bank of Mysore Extension Counter, PESIAMS Campus, Shivamogga. The bank account shall be operated jointly by the President and the Treasurer.

12.5 The Executive Committee shall have the power to invest excess funds available in the bank account in bank fixed deposits for appropriate maturities. However, the funds of the Association shall not be invested in any other forms like bonds, shares, gold, etc.

13. Records of the Association

The following records shall be maintained by the office of the Association. The records shall include details of all sums of money received and the sources, fixed deposits and all the sums of money spent.

13.1 Roll of Membership

13.2 Minutes of the Executive Committee Meetings

13.3 Minutes of the General Body Meetings

13.4 Stock Register of non-consumable and consumable items

13.5 Cash book and Ledger

13.6 Copies of all publications and reports of the Association

14. Dissolution Clause

In the event of dissolution or winding up of PESIAMSAA, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Executive Committee/ General Body of PESIAMSAA; but the same shall be transferred PES Institute of Advanced Management Studies, Shivamogga - 577 204.

15. Disputes, Suits and Proceedings against the Association

15.1 All unresolved dispute shall be referred to Patron and his/ her decision shall be final and binding on all parties.

15.2 The President or any office bearer authorized by the Executive Committee may sue on behalf of the Association. When the Association is being sued, the president will represent the Association.

15.3 No suit or proceeding shall fail by the reason of any vacancy or change in the holder of the office of the Secretary or any office bearer authorized on its behalf.

15.4 Every decree or order against the Association in any suit or proceeding shall be executable against the property of the Association and not against the property of the President. By-Laws of PESIAMS Alumni Association

15.5 Nothing herein shall exempt the President or any office bearer of the Association from any criminal liability entitle him/ her to claim any contribution from property of the Association in respect of any claim paid by him/ her on conviction by criminal court unless it is attributable to Association matters.

15.6 No member or the Association shall be sued or prosecuted by the Association except for any injury, loss, damage, misappropriation of funds, detention or destruction of any property of the Association.

16. General

16.1 Members of the Association shall be kept informed about its activities either through circulars, newsletters, e-mails, electronic messaging and/ or any other means considered appropriate by Executive Committee.

16.2 Members desirous of proposing amendments to the Constitution of the Association are required to submit the same in writing to the Executive Committee at least 07 days prior to the Annual General Body Meeting. The amendments shall be passed only if Quorum (Ref. 10.7) in the AGM supports the amendment(s) through simple majority voting.

16.3 Financial year of the Association shall be from 1st April to 31st March. However, at the Annual General Body meeting the Treasurer will present the statement of accounts for the period since the date of hold of previous Annual General Body meeting.





16.4 Every member of the General Body shall have the right of inspection of records of the Association during office hours.

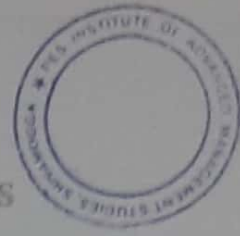


PESIAMS Alumni Meet 2018 Return Relieve Relate
