Whereas with a view to secure proper and permanent administration of this Trust, it is considered desirable to execute a deed of declaration of Trust.








- (9) To aid poor students for acquiring knowledge in different fields of study and if possible and feasible may provide them shelter, food, during their period of study.
- (10) To conduct religious and spiritual discourses lectures, seminars, workshops, conferences, etc., to promote and inculcate the spiritual knowledge amongst the members of the public.
- (11) To chalk out plans for constructions, development of buildings, required for the purposes of the Trust and its activities from the Trust funds and seek approval of plans, layouts, etc., formed or effectuated by the Trust for its activities.
- (12) To pay, grant or give scholarships, stipends, prizes, rewards, allowances and other financial assistance or help in cash or kind to students deserving with a view to help them in prosecuting their studies in schools, colleges, educational institutions, technical / professional institutions, institution of teaching or providing commerce and other Arts, including teaching of cultural, arts and other training, research or educational work in India and Abroad.

Provided always that the beneficiaries of the Trust hereby created shall not be restricted to any community or creed but the Trust shall be for the benefit of the society at large and both the corpus and the income of the Trust shall be applied and expended wholly and exclusively in India and Abroad.

- (17) The trust is entitled to create an advisory committee, consisting of very eminent persons in various academic fields, to guide the trust on all matters, pertaining to education and incidental affairs thereof.
- (18) To impart quality education, to encourage merit and wherever necessary to associate itself with any other trusts or educational institutions on such schemes or on joint venture basis, as may be decided by the trustees from time to time. To advance and promote communal harmony among the public.
- (19) To take up various activities, for promoting the welfare and well being of the children and students, particularly from the rural areas.

- (20) To render meaningful support, assistance to research students and teachers in the interest of the nation. To provide the required counseling to the needy students.
- (21) To decide from time to time, the various projects and activities to be undertaken by the trust, for purposes of implementing the objectives of the trust.
- (22) To constitute or form committees or sub-committees or faculty for drawing up sound schemes, for imparting globally competitive education and to improve the moral, ethical standards among the students.
- (23) To give donations to the charitable institutions provided that such institutions are eligible to get the exemption u/s 80G of the Income Tax Act, 1961.
- (24) To encourage sports of various types and to arrange games and competitions for the physical and mental development, to arrange for study tours, summer camps, free counseling centres, etc.,
- (25) To promote small scale & cottage industries and to establish training project, community development programme and other related activities for the social welfare particularly for women and children.
- (26) To undertake such other projects of environmental and national importance like literacy drives, environmental awareness programmes, adult education programmes, etc.
